Why I am receiving this notice? A Settlement has been reached in a class action lawsuit filed against Zenith American Solutions, Inc. ("Zenith" or "Defendant") regarding a data security incident, discovered on or about September 6, 2024, involving unauthorized access to a single employee email account, as a result of which certain files containing Private Information may have been accessed or acquired by an unauthorized third party (the "Data Incident"). The Parties entered into an agreement to settle the lawsuit, without admission of liability or wrongdoing, to avoid the risks, costs, and uncertainties of continued litigation. Who is included in the Settlement? In the lawsuit *David Black, et al v. Zenith American Solutions, Inc.*, Case No. CACE-26-009568, 17th Judicial Circuit, Broward County, Florida, you are a Settlement Class Member if you are an individual residing in the United States who was sent a notice from Zenith that your Private Information may have been accessed in the Data Incident.

What are the Settlement benefits? Settlement Class Members who submit a Valid Claim may elect either: (a) Cash Payment A – Documented Losses of up to \$2,500.00 for documented, unreimbursed losses relating to fraud and/or identity theft incurred as a result of the Data Incident; or (b) Cash Payment B – Alternate Cash Payment of \$45.00, available exclusively to Settlement Class Members whose Social Security number may have been disclosed in the Data Incident (subject to a \$40,000.00 aggregate cap and proportionate reduction if the cap is reached). In addition, all Settlement Class Members are entitled to one year of CyEX Financial Shield Complete credit monitoring — no Claim Form is required — by activating directly through CyEX the code printed on the front of this notice at <http://app.financialshield.com/enrollment/activate/zenith>.

How do I receive a benefit? To claim the Cash Payment B - Alternate Cash Payment, simply complete the attached Claim Form, tear at the perforation, or call (866) 455-1359. Claims must be submitted online or postmarked by SEPTEMBER 25, 2026.

Who represents me? The Court has been asked to appoint Jeff Ostrow of Kopelowitz Ostrow P.A. and Marya Weekes of Milberg PLLC to represent the Settlement Class ("Class Counsel").

What if I don't want to participate in the Settlement? You may exclude yourself from the Settlement and retain your ability to sue Defendant on your own by mailing a written request to opt-out postmarked no later than SEPTEMBER 11, 2026. If you exclude yourself, you cannot get any Cash Payment from this Settlement. If you do not exclude yourself, you have the right to object to the Settlement. Objections must be filed with the Court and mailed no later than SEPTEMBER 11, 2026. The Long Form Notice and Settlement Agreement, available at WWW.ZENITHDATAINCIDENTSETTLEMENT.COM, explain how to exclude yourself or object.

When will the Court decide whether to approve the Settlement? The Court will hold a hearing in this case on OCTOBER 12, 2026, at 9:30 a.m. and Service Awards of up to \$1,500.00 for each Class Representative. You may attend the hearing at your own cost, but you do not have to. and consider whether to approve the Settlement. The Court will also consider Class Counsel's application for attorneys' fees and costs of \$185,000.00 to and Service Awards of up to \$1,500.00 for each Class Representative. You may attend the hearing at your own cost, but you do not have to.
